Canadian Premier League Final "Tug of War" Contest

Official Rules and Regulations

1. CONTEST PERIOD

The Canadian Premier League Final "Tug of War" Contest (the "Contest") begins on **Thursday November 6**, at 12:00 PM ET and closes on **Sunday, November 9**, 2025, at 4:00 PM ET ("Contest Closing Date"). Entries submitted after this time will not be accepted. Kickoff for the CPL Final is scheduled for 5:00 PM ET.

2. ELIGIBILITY

The Contest is open to **legal residents of Canada**, excluding residents of **Quebec**, who have reached the **age of majority** in their province or territory of residence at the time of entry. Employees, representatives, and agents of the **Canadian Premier League ("CPL")**, **Canadian Soccer Business**, their affiliated companies, advertising or promotional agencies, and the immediate family members or household members of any of the above are **not eligible** to enter.

3. HOW TO ENTER

No purchase necessary.

To enter, participants must:

- 3. Complete and submit the entry form, including name, valid email address, and team prediction before **4:00 PM ET**on the Contest Closing Date.

Limit of **one (1) entry per person** during the Contest Period. Any attempt to exceed this limit (e.g., through multiple accounts or automated entries) will result in disqualification.

4. PRIZE DESCRIPTION

There is **one (1) prize** available to be won.

The prize consists of:

 One (1) official jersey from each of the two teams participating in the CPL Final (for a total of two jerseys). Approximate total retail value of the prize: \$300 CAD.

The prize must be accepted as awarded, has **no cash value**, and is **non-transferable** or **substitutable**, except at the CPL's sole discretion.

5. WINNER SELECTION

Following the conclusion of the CPL Final, all eligible entries that correctly predicted the winning team will be placed into a random draw.

- The draw will take place on or about **Monday, November 10, 2025**, at the CPL offices in Toronto, Ontario.
- Odds of winning depend on the number of eligible entries received and the number of correct predictions.

6. WINNER NOTIFICATION AND SKILL-TESTING QUESTION

The selected entrant will be contacted by email within **48 hours** of the draw.

To be declared a winner, the selected entrant must:

- 1. Respond to the notification within **five (5) business days**;
- 2. Correctly answer, without assistance, a mathematical skill-testing question, for example:

$$(10 \times 2) + (8 \div 4) - 6 = ?$$

Complete and return a **Declaration and Release Form** confirming eligibility and compliance with these Rules.

Failure to comply with any of the above conditions will result in disqualification and selection of an alternate winner.

7. GENERAL CONDITIONS

- The CPL reserves the right to cancel, suspend, or modify this Contest in any way, without notice, in the event of fraud, technical failure, or any other cause beyond its control.
- The CPL and its affiliates assume no responsibility for lost, late, misdirected, or incomplete entries or for any technical malfunction or human error.
- By entering, participants agree to be bound by these Rules and the decisions of the CPL, which are final and binding.

 By accepting the prize, the winner consents to the use of their name, likeness, and city/province of residence for publicity purposes in any media without further compensation, unless prohibited by law.
