

Canadian Premier League “12 Days of Giveaways Presented by Telus” Contest

Official Rules and Regulations

1. CONTEST PERIOD

The *Canadian Premier League “12 Days of Giveaways Presented by Telus”* (the “Contest”) begins on **Monday December 1, at 12:00 AM ET** and closes on **Saturday, December 13, 2025, at 11:59 PM ET** (“Contest Closing Date”). Entries submitted after this time will not be accepted.

2. ELIGIBILITY

The Contest is only open to legal residents of Canada, excluding Quebec, who have reached the age of majority in their province or territory at the time of entry. Employees, officers and directors, and the immediate family members and/or those with whom such employees, officers and directors are domiciled, of Telus, the Canadian Soccer Business (“CSB”), the Canadian Premier League (the “CPL”), CPL member teams, prize suppliers, and advertising/promotion agencies and their respective parent companies, subsidiaries, affiliates (collectively, “CPL Entities”) are not eligible to enter or win. For the purpose of these Official Rules, “immediate family members” means parent, spouse, sibling or child and their respective spouses. The CPL reserves the right to verify the eligibility of the winner.

1. Visit the official CPL Contest Page or designated platform (promotional banners, social posts, buttons, or links) during the Contest Period.
2. Complete and submit the entry form as instructed during the applicable entry period, including all required information such as full name, phone number, valid email address, postal code, city, province, and favourite club before 11:59 PM ET on the Contest Closing Date.

Limit of one (1) entry per person for the corresponding entry form day during the Contest Period from December 2 to 12.

Following the conclusion of the 12 Days of Giveaways Presented by Telus, all eligible entries placed will have a random draw selected for each corresponding day. The odds of winning the prize will depend on the total number of eligible entries received in each of the contest periods.

6. WINNER NOTIFICATION AND SKILL-TESTING QUESTION

The selected entrant for the Prize will be contacted via email or by telephone by a representative of the CPL Entities within two business days (48 hours) of the draw date.

To be declared a winner, the selected entrant must:

1. Correctly answer, **without assistance**, a **mathematical skill-testing question**, for example:

$$(20 \times 2) + (12 \div 4) - 6 = ?$$

3. Complete and return a **Declaration and Release Form** confirming eligibility and compliance with these Rules.

Failure to comply with any of the above conditions will result in disqualification and selection of an alternate winner.

If the potential winner cannot be reached OR in the event a potential winner does not accept the prize or fails to comply with these rules and requirements within **two (2) business days of being contacted**, the Prize will be forfeited. Upon prize forfeiture, no compensation will be given, and the CPL Entities will have sole discretion to randomly select another potential winner.

Before being declared a Prize winner, the selected entrant will be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question and will also be required to sign, and in the event of a minor, have his/her parent or
